
*Please take notice that the Court, Second Division, issued a Resolution dated **23 February 2022** which reads as follows:*

**“A.C. No. 13154 (Jennylyn Malto v. Atty. Dionisio B. Apoya, Jr.). –** The Court **NOTES** the Notice of Resolution<sup>1</sup> dated June 27, 2020 of the Integrated Bar of the Philippines (IBP) Board of Governors, which adopted and approved the report and recommendation<sup>2</sup> of the Commissioner on Bar Discipline dated May 2, 2019 to dismiss the complaint against Atty. Dionisio B. Apoya, Jr. for lack of merit.

Finding the recommendation of the Commissioner on Bar Discipline and the IBP Board of Governors to be fully supported by the evidence on record and by applicable laws and jurisprudence, the Court **RESOLVES** to **ADOPT** and **APPROVE** the recommendation to dismiss the case against Atty.
