#### Abstract

"A.C. No. 13761 (Virginia M. Palma v. Atty. Nicolas C. Pineda"). After a careful review of the records of this case, the Court resolves to adopt the findings ${ }^{1}$ of the Integrated Bar of the Philippines Board of Governors and dismiss the administrative case filed by complainant Virginia M. Palma for her failure to show that respondent Atty. Nicolas C. Pineda is unfit to practice law and to be entrusted with the duties and responsibilities pertaining to the office of an attorney.
