“A.C. No. 13783 [Formerly CBD Case No. 21-6582] (BEN-HUR PIO R. ORTIZ II and RYAN P. HERRERA, Complainants v. ATTY. ROLANDO G. ANDAYA, JR.,¹ Respondent). – The Court **NOTES** the Notice of Resolution² No. CBD-XXV-2022-12-09 dated December 3, 2022 of the Integrated Bar of the Philippines – Board of Governors (IBP-BOG) which resolved to dismiss the complaint against respondent on account of his death; transmitted by Letter³ dated February 8, 2023 of Director Avelino V.
