

The *Supreme Court of the Philippines* through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), intends to procure through Negotiated Procurement pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations of RA 9184 for the construction of the Hall of Justice in San Isidro, Davao Oriental with an Approved Budget for the Contract (ABC) in the amount of **Seven Million Five Hundred Thousand (₱7,500,000.00)**, chargeable against the amount allotted for Locally Funded Projects under the General Appropriation Act for FY 2018. The duration for the subject project is for a period of One Hundred Fifty (15) calendar days.

Negotiated Procurement is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **Category "D" size range "Small "B"** for general building.

4. Interested bidders may obtain further information Supreme Court of the Philippines and inspect the Bidding Documents at the address given below from 8:00 a.m. to 4:30 p.m.
