1. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Bidders should have completed, at least one (1) contract that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least "Small B" for general building.

5. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.

8. The Pre-Bid Conference shall be open to all interested parties.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
10. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend, at the Conference Room, Office on Halls of Justice, 7th floor, Centennial Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila. Late bids shall not be accepted.
11. The *Supreme Court of the Philippines* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. In instances that may arise and not specifically mentioned herein, the *Supreme Court of the Philippines* shall resolve bidding issues by resorting to and applying the pertinent provisions of R.A. No. 9184 and its Implementing Rules and Regulations.


