Resolution No. 2019-34

RE: AWARD OF THE CONTRACT FOR THE EMERGENCY PROCUREMENT FOR THE REPAIR OF FIRE SUPPRESSION SYSTEM, UNINTERRUPTIBLE POWER SUPPLY (UPS) AND PRECISION AIR CONDITIONING UNIT (PACU) FOR THE JUDICIARY DATA CENTER (JDC)

WHEREAS, the Bids and Awards Committee for Goods and Services (SC-BAC-GS) received the 1st Indorsement dated September 17, 2019 of the Procurement Planning Committee (PPC) relative to the Emergency Procurement for the Repair of Fire Suppression System, Uninterruptible Power Supply (UPS) and Precision Air Conditioning Unit (PACU) for the Judiciary Data Center (JDC) with an approved budget for the contract (ABC) in the amount of One Million Four Hundred Nine Thousand Seven Hundred Twenty-One Pesos & 60/100 (₱1,409,721.60), with attachments as follows:

- Approved Memorandum of Mr. Jovito M. Salonga, SC Chief Judicial Staff Officer, MISO-SPPED dated August 30, 2019 for the Emergency Procurement for the Repair of Fire Suppression System, Uninterruptible Power Supply (UPS) and Precision Air Conditioning Unit (PACU) for the Judiciary Data Center (JDC), wherein the enduser justified and requested for the resort to Emergency Procurement pursuant to Section 53 (b) of R.A. No. 9184 and Section 53 (2) of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184. The Memorandum was approved by the Chief Justice on September 4, 2019 with the instruction that the negotiation be made through the SC-BAC-GS;
- 2. Certificate of Availability of Funds dated September 12, 2019.

WHEREAS, pursuant to the approved memorandum and upon preparation of the appropriate procurement documents, the SC-BAC-GS commenced the negotiation procedures for the emergency procurement;

WHEREAS, on October 1, 2019, the SC-BAC-GS submitted a letter to PrimeBiz ICT Solution Systems Integration & Technologies, a supplier recommended by the end-user, requesting for its quotation and submission of documentary requirements;

WHEREAS, on October 8, 2019, the day of the submission of the quotation and negotiation meeting, the SC-BAC-GS, together with the representatives of the end-users, negotiated with PrimeBiz ICT Solution Systems Integration & Technologies;

WHEREAS, PrimeBiz ICT Solution Systems Integration & Technologies tendered its quotation on October 8, 2019 in the amount of One Million Four Hundred Nine Thousand Seven Hundred Twenty-One Pesos & 60/100 (P1,409,721.60);

WHEREAS, after the negotiation conducted by the SC-BAC-GS and the representatives of the end-users on October 8, 2019 and after the submission of the complete requirements on November 6, 2019, PrimeBiz ICT Solution Systems Integration & Technologies was found to possess the technical, legal and financial capability to deliver the goods, execute the works and perform the services to address the emergency;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:

- 1. recommend to the Honorable Chief Justice the award of the Contract for the Repair of Fire Suppression System, Uninterruptible Power Supply (UPS) and Precision Air Conditioning Unit (PACU) for the Judiciary Data Center (JDC), to PRIMEBIZ ICT SOLUTION SYSTEMS INTEGRATION & TECHNOLOGIES in the amount of One Million Four Hundred Nine Thousand Seven Hundred Twenty-One Pesos & 60/100 (₱1,409,721.60); and
- 2. should the Chief Justice approve the SC-BAC-GS recommendation, it is further requested that ATTY. EDGAR O. ARICHETA, Clerk of Court, Supreme Court, be authorized to sign the contract with the supplier for the Repair of Fire Suppression System, Uninterruptible Power Supply (UPS) and Precision Air Conditioning Unit (PACU) for the Judiciary Data Center (JDC).
