BIDS AND AWARDS COMMITTEE FOR HALLS OF JUSTICE

INVITATION TO BID FOR THE PROCUREMENT OF A WORKS CONTRACTOR FOR THE REFURBISHMENT (*WITH SUPPLY AND DELIVERY OF FURNITURE AND EQUIPMENT*) OF A LEASED PROPERTY TO HOUSE THE SEVEN NEWLY CREATED REGIONAL TRIAL COURTS AND ONE (1) FAMILY COURT OF MANDAUE CITY

1. *The Supreme Court of the Philippines, through the Local Bank Account of the Supreme Court, intends to apply the sum of Thirteen Million Three Hundred Forty Eight Thousand Three Hundred Pesos and 60/100 (₱13,348,300.60) being the Approved Budget for the Contract (ABC) to payments under the contract for Refurbishment of a leased property to house the Seven (7) newly created Regional Trial Courts and One (1) Family Court of Mandaue City. Bids received in excess of the ABC shall be automatically rejected at bid opening.*
2. *The Supreme Court of the Philippines now invites bids for Refurbishment of a leased property to house the Seven (7) newly created Regional Trial Courts and One (1) Family Court of Mandaue City. Completion of the Works required is for One Hundred Fifty (150) Calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.*
3. *Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”*

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least Category “D” and size range of Small B. Interested bidders may obtain further information *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from **8:00 a.m. to 4:30 p.m.**

4. *A complete set of Bidding Documents may be purchased on **14 March 2018 – 10 April 2018** by interested bidders from:*

and upon payment of a nonrefundable fee of **Five Thousand Pesos (₱ 5,000.00)** for Bidding Documents.

5. *The Supreme Court of the Philippines will hold a Pre-Bid Conference on **22 March 2018, 9:30 a.m.** at the **Office DCA Raul Bautista Villanueva, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila**, which shall be open to prospective bidders.*

6. The Pre-Bid Conference shall be open to all interested parties.
7. Bids must be duly received by the **BAC Secretariat** at the address below on or before **10 April 2018, 9:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.

Bid opening shall be on **10 April 2018, 9:30 a.m.** at **Office DCA Raul Bautista Villanueva, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Supreme Court of the Philippines** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
