BIDS AND AWARDS COMMITTEE FOR HALLS OF JUSTICE

INVITATION TO BID FOR THE PROCUREMENT OF A WORKS CONTRACTOR/S FOR THE CONSTRUCTION OF HALL OF JUSTICE IN BALIUAG, BULACAN

1. The *Supreme Court of the Philippines* through the amount allotted for Locally Funded Projects under the General Appropriation Act for FY 2018 (R.A.10964) intends to apply the total amounts of **Seven Million Five Hundred Thousand (₱7,500,000.00)** being the Approved Budget for the Contracts (ABC) to payment under the contract for the construction of the Hall of Justice in Baliuag, Bulacan. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Supreme Court of the Philippines now invites bids for the construction of the Hall of Justice in Baliuag, Bulacan. The required period for the completion of the work is **One Hundred Fifty (150) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **"Small "B"** for general building.

4. Interested bidders may obtain further information *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from **8:00 a.m. to 4:30 p.m.**
5. A complete set of Bidding Documents may be purchased on **22 April 2019 to 21 May 2019** by interested bidders from the Office on Halls of Justice, 7th Floor, Centennial Building, Supreme Court of the Philippines, Padre Faura, Ermita Manila and upon payment a non-refundable fee of **Ten Thousand Pesos (Php10,000.00)**

6. The *Supreme Court of the Philippines* will hold a **Pre-Bid Conference** on **07 May 2019, 9:30 a.m.** at the **Office of Hon. Raul Bautista Villanueva, Deputy Court Administrator and Chairperson, Bids and Awards Committee for Halls of Justice, 3rd floor, Old Main Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila**, which shall be open to prospective bidders.
7. The Pre-Bid Conference shall be open to all interested parties.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **21 May 2019, 9:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 12.1.b.

Bid opening shall be on **21 May 2019, 9:30 a.m.** at the Office of Hon. Raul Bautista Villanueva, Deputy Court Administrator and Chairperson -Bids and Awards Committee for Halls of Justice, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The ***Supreme Court of the Philippines*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
