BIDS AND AWARDS COMMITTEE FOR THE HALLS OF JUSTICE

**INVITATION FOR NEGOTIATED PROCUREMENT OF SECURITY SERVICES
FOR THE HALLS OF JUSTICE IN VARIOUS REGIONS**

1. Pursuant to Resolution dated August 8, 2017 of the Supreme Court *en banc* in A.M. No. 12-6-17-SC approving the recommendation to conduct negotiated procurement after two (2) failed biddings under Section 53.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act”, the Bids and Awards Committee for the Halls of Justice (BAC-HOJ) invites interested security agencies to participate in the negotiations for security services for the Halls of Justice in the following regions/clusters:

Region/Cluster	Number of Security Guards	Approved Budget for the Contract (One [1] Year)
Region IX – Zamboanga Peninsula	58	Php8,839,474.45
Region X – Northern Mindanao	87	Php14,669,222.80
Autonomous Region in Muslim Mindanao	21	Php2,803,928.28

2. Delivery of security services for each region/cluster will be for a period of two (2) years.
3. Bidders should have completed, within ten (10) years from the date of submission and receipt of offers, a contract similar to the project equivalent to at least fifty percent (50%) of the ABC of the region/s where it intended to bid.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.


6. A complete set of Bidding Documents will be available starting 11 June 2018 from the Receiving Section, Office on Halls of Justice, 7th Floor, Centennial Building, Supreme Court, Padre Faura, Manila
7. The *Supreme Court of the Philippines*, through the BAC-HOJ, will hold the following procurement activities in the ***Office on Halls of Justice, 7th Floor Centennial Building, Supreme Court, Padre Faura St., Manila***, under the following schedule:

1. Deadline for the Submission of Eligibility Documents	July 3, 2018, 9:00 a.m.
2. Opening of Eligibility Documents	July 3, 2018, 9:30 a.m.
3. Pre-Negotiation Conference	July 10, 2018, 9:30 a.m.
4. Deadline for Submission of Proposals	July 24, 2018, 9:00 a.m.
5. Opening of Proposals	July 24, 2018, 9:30 a.m.

8. The Pre-Negotiation Conference shall be open to all interested parties.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
10. Proposals will be opened in the presence of the interested security agencies, or their representatives, who choose to attend. Proposals submitted beyond the deadline given above shall not be accepted.
11. The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
