## **BIDS AND AWARDS COMMITTEE FOR HALLS OF JUSTICE**

### **INVITATION TO BID FOR WORKS CONTRACTOR FOR THE REFURBISHMENT OF THE HALL OF JUSTICE OF TAGAYTAY CITY**

1. *The Supreme Court of the Philippines, through the Local Bank Account of the Supreme Court, intends to apply the sum of **Five Million Eighty Nine Thousand Five Hundred Seventy Seven Pesos and 40/100 (₱5,089,577.40)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Refurbishment of the Hall of Justice of Tagaytay City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.*
2. *The **Supreme Court of the Philippines** now invites bids for the **Refurbishment of the Hall of Justice of Tagaytay City**. Completion of the Works are required **One Hundred Fifty (150) Calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.*
3. *Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”*
4. *Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **Category “D”** and size range of **Small B**. Interested bidders may obtain further information **Supreme Court of the Philippines** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 4:30 p.m.***
5. *A complete set of Bidding Documents may be purchased on **18 June 2018 to 17 July 2018** by interested Bidders from the:*

6. *The **Supreme Court of the Philippines** will hold a Pre-Bid Conference on **05 July 2018, 9:00 a.m.** at the **Hall of Justice of Tagaytay City** which shall be open to prospective bidders.*
7. *The Pre-Bid Conference shall be open to all interested parties.*
8. *Bids must be duly received by the **BAC Secretariat** at the address below on or before **17 July 2018, 9:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 12.1.b**.*
9. *Bid opening shall be on **17 July 2018, 9:30 a.m.** at the **Office of DCA Raul Bautista Villanueva,***


