**Procurement of Service Vehicles for the Official Use of Associate Justices
of the Supreme Court
(Two [2] Units of Sports Utility Vehicle, Gasoline-Fed)**

On March 16, 2020, Administrative Circular No. 31-2020 was issued by Honorable Chief Justice Diosdado M. Peralta wherein all courts nationwide were directed to drastically reduce its operations due to the rising cases of Covid-19 infections. Consequently, all official meetings including meetings of the bids and awards committees and other committees were deferred. Thus, the conduct and period of all procurement activities related to the above-mentioned project were suspended and tolled as of March 16, 2020.

Considering that the National Capital Region was placed under General Community Quarantine beginning June 01, 2020, Administrative Circular No. 41-2020 dated May 29, 2020 was issued by the Honorable Chief Justice declaring that all courts and offices of the courts nationwide shall be in full operation beginning June 01, 2020. All official meetings shall be deferred unless conducted through videoconferencing except those that maybe authorized by the Chief Justice.

Notice is therefore given that as of June 01, 2020, with the issuance of the abovementioned circular, the suspension of the conduct and the tolling of the period of procurement activities for the subject procurement has been lifted. Hence, the resumption of procurement activities commenced as of said date.

Pursuant to the Supreme Court Workplace Protocol (Memorandum Circular No. 04-2020 dated May 22, 2020), no actual meetings in the Supreme Court shall take place except those that maybe called or authorized by the Chief Justice. In the letter of the undersigned dated June 16, 2020, authority was sought to the Honorable Chief Justice for the conduct of a blended mode of videoconferencing and actual face to face meeting, and the same approved on the same day, June 16, 2020.

In view of the resumption of procurement activities and with the approval of the Chief Justice of the blended mode of videoconferencing and actual face to face meeting, the following is the schedule of procurement activities for the above-mentioned project:
