**Procurement of Comprehensive Health Care Plan to All Lower Courts Personnel  
of the 1st and 2nd Level including Shari'a Courts**

The Supreme Court, through the Appropriations of the Lower Courts in CY 2019, intends to apply the sum of **One Hundred Sixty Six Million Four Hundred Thousand Pesos (P166,400,000.00) inclusive of Value-Added Tax**, being the Approved Budget for the Contract (ABC), to payments under the contract for the **Procurement of Comprehensive Health Care Plan to All Lower Courts Personnel of the 1st and 2nd Level including Shari'a Courts** (Project). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Supreme Court now invites bids for the above-stated procurement. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the Supreme Court, and inspect the Bidding Documents at the address given below from **9:00 a.m. to 4:00 p.m.**

A complete set of Bidding Documents may be acquired by interested bidders starting **October 18, 2019**, between **9:00 a.m. and 4:00 p.m.**, from the address below and upon payment of nonrefundable fees for the Bidding Documents, pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB), in the amount of **Thirty One Thousand Five Hundred Pesos (P31,500.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Supreme Court, provided that bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The Supreme Court will hold the **Pre-Bid Conference** on **October 29, 2019** at the **OCA Conference Room 1, 3<sup>rd</sup> Floor, Supreme Court Old Building, Taft Avenue, City of Manila** at **1:00 p.m.**, which shall be open to all interested parties.


Bids must be delivered to the address below **on or before November 11, 2019 at 12:00 noon**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall immediately follow at **2:30 p.m.** of the abovementioned date of bid submission at the **OCA Conference Room 1, 3<sup>rd</sup> Floor, Supreme Court Old Building, Taft Avenue, City of Manila** in the presence of the bidders' representatives who choose to attend at the given address. Late bids shall not be accepted.

The Supreme Court reserves the right to accept or reject any bid, annul the bidding process, and reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
