INVITATION TO BID FOR WORKS CONTRACTOR FOR THE CONSTRUCTION AND
REPAIR AND REHABILITATION OF VARIOUS HALLS OF JUSTICE

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the construction and repair and rehabilitation of the following Halls of Justice, with their respective Approved Budget for the Contract chargeable against the Local Bank Account of the Supreme Court of the Philippines:

1	Flora, Apayao (Construction)	P7,500.000.00	150 calendar days
2	Tanay Rizal (MTC) (Construction)	P7,500.000.00	150 calendar days
3	Cabagan, Isabela (Repair and Rehabilitation)	P11,218,815.00	240 calendar days

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed, at least one (1) contract that is similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least "**Category 'D', Size Range Small 'B'**" for general building.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.
7. A complete set of Bidding Documents may be purchased on **19 November 2018 to 18 December 2018** by interested Bidders from the –

and upon payment of the following non-refundable fee of Ten Thousand Pesos (Php10,000.00) for the projects in Flora, Apayao and Tanay, Rizal (MTC) and (P25,000.00) for the Cabagan, Isabela project.

10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
11. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend, at the Office of DCA Raul Bautista Villanueva, 3F Old Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila. Late bids shall not be accepted.

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of the 2016 Revised Implementing Rules and Regulations of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
