**RE: AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF TONER CARTRIDGES, HP-
CF 226XC, FOR ISSUANCE TO THE LOWER
COURTS WITH HP LASER JET PRO MFP M426
FDW PRINTERS**

WHEREAS, the SC-BAC-GS received the 1st Indorsement dated April 2, 2019 from the Procurement Planning Committee relative to the *Procurement of Toner Cartridges, HP-CF 226XC, for Issuance to the Lower Courts with HP Laser Jet PRO MFP M426 FDW Printers* with an Approved Budget for the Contract (ABC) in the amount of Eighty-Five Million Five Hundred Sixty-Seven Thousand Fifty Pesos (P85,567,050.00) inclusive of taxes;

WHEREAS, on the basis of the said Indorsement and after the conduct of the Pre-Procurement Conference on April 30, 2019, the SC-BAC-GS caused the posting of the Invitation to Bid on May 20, 2019 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, three (3) prospective bidders attended the pre-bid conference on May 28, 2019, namely:

1. Advance Solutions, Inc.
2. HP, Inc.
3. Integrated Computer Systems, Inc.

WHEREAS, two (2) prospective bidders, Advance Solutions, Inc. and Integrated Computer Systems, Inc., purchased the bidding documents and paid the non-refundable fee of Twenty-Seven Thousand Five Hundred Pesos (P27,500.00) to cover the cost for the preparation of the said bidding documents;

WHEREAS, on the day of the submission of bids and opening of bids on June 13, 2019, both Advance Solutions, Inc. and Integrated Computer Systems, Inc. submitted their respective bids. Both were declared eligible and qualified after the opening and evaluation of its Eligibility/Technical and Financial Envelopes;



WHEREAS, the following are the financial bid tendered:

Advance Solutions, Inc.	₱45,789,277.00
Integrated Computer Systems, Inc.	₱52,402,437.50

WHEREAS, the bid of Advance Solutions, Inc. in the amount of *Forty-Five Million Seven Hundred Eighty-Nine Thousand Two Hundred Seventy-Seven Pesos (₱45,789,277.00)* was declared as the *Lowest Calculated Bid*, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued on June 19, 2019 to Advance Solutions, Inc. which upon its receipt submitted the documents within the prescribed period;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification inspection was conducted by the SC-BAC-GS and the representatives of the end-user on July 5, 2019 which consisted of the ocular inspection of the premises and facilities of Advance Solutions, Inc.;


WHEREAS, in its Post-Qualification Report dated July 15, 2019, the post-qualification inspection team found no ground to post-disqualify the bid of Advance Solutions, Inc.;

WHEREAS, after review and evaluation of the findings of the post-qualification inspection team on Advance Solutions, Inc.'s documentary submissions and the ocular inspection of its premises, the SC-BAC-GS is of the view that Advance Solutions, Inc. has met the requirements of the Supreme Court and declared its bid as the *Lowest Calculated and Responsive Bid*;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. recommend the award of the contract for the *Supply and Delivery of Toner Cartridges, HP-CF 226XC, for Issuance to the Lower Courts with HP Laser Jet PRO MFP M426 FDW Printers* to **ADVANCE SOLUTIONS, INC.** in the amount of *Forty-Five Million Seven Hundred Eighty-Nine Thousand Two Hundred Seventy-Seven Pesos (₱45,789,277.00)*, inclusive of taxes; and
2. request that **HON. JOSE MIDAS P. MARQUEZ**, Court Administrator, be authorized to sign the contract with the winning bidder.


