“**A.C. No. 13596** [*Formerly CBD Case No. 15-4819*] (**Jaime E. Ligtas, Complainant versus Atty. Portia D. Flores-Diesta, Respondent**). – The Notice of Resolution dated February 16, 2019 of the Board of Governors of the Integrated Bar of the Philippines (IBP) is **NOTED**.
