## Procurement of Ambulance for the Supreme Court

- 1. The **Supreme Court**, through its Local Bank Account, intends to apply the sum of *Two Million Eleven Thousand One Pesos* (₱2,011,001.00), inclusive of Value-Added Tax, being the Approved Budget for the Contract (ABC) to payments under the contract for the *Procurement of Ambulance for the Supreme Court* − **ITB No. 2021-08.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Supreme Court** now invites bids for the above Procurement Project. Complete supply and delivery of the Goods is required by **thirty (30) calendar days from receipt of the Purchase Order via e-mail**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from SC-BAC-GS Secretariat and inspect the Bidding Documents at the address given below during office hours from Mondays to Fridays at 9:00 AM to 3:00 PM.
- A complete set of Bidding Documents may be acquired by interested Bidders starting **March 1**, **2021** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Two Thousand Five Hundred Pesos** (**P2,500.00**). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The Supreme Court will hold a Pre-Bid Conference on March 9, 2021, 2:00 p.m. within its premises and/or through video conferencing or webcasting via Microsoft Teams, which shall be open to prospective bidders. Prospective bidders are advised to send a letter of intent containing the names and email addresses of interested participants on or before March 8, 2021, 3:00 p.m. Kindly coordinate with the SC-BAC-GS Secretariat prior to said date for further details and instructions.
- 7. Bids must be duly received by the SC-BAC-GS Secretariat through manual submission at the office address indicated below on or before **March 22, 2021, 2:00 p.m.** Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on **March 23, 2021, 1:00 p.m.** at the given address below and/or via **Microsoft Teams**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, via video-conferencing.
- 10. The **Supreme Court** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
