**INVITATION TO BID FOR WORKS CONTRACTOR FOR THE REFURBISHMENT OF
LEASED PROPERTY TO HOUSE THE FOUR (4) NEWLY CREATED REGIONAL TRIAL
COURTS IN BACOR CITY, CAVITE**

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the refurbishment of leased property to house the four (4) newly created Regional Trial Courts in Bacoor City, Cavite with an Approved Budget for the Contract (ABC) in the amount of **Nine Million Eight Hundred Sixty-Nine Thousand One Hundred Sixty Pesos, (₱9,869,160.00.00)**, chargeable against the amount allotted for Repairs and Maintenance under the General Appropriation Act (GAA) for FY2020. The duration for the subject project is for a period of One Hundred (100) calendar days.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed at least one (1) contract that is similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **Category "C or D", Size range Small "B"** for general building.

6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.

9. The Pre-Bid Conference shall be open to all interested parties through videoconference via Zoom. The mechanics thereof will be provided in a bid bulletin to be issued before the pre-bid conference.
10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
11. Bids shall be physically submitted in the Supreme Court on or before the given deadline. Late bids shall not be accepted.
12. Bids will be opened in the presence of the bidders, or their representatives, through videoconference via Zoom. The mechanics thereof will be provided in a bid bulletin to be issued.

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
