**INVITATION TO BID FOR WORKS CONTRACTOR FOR THE
REFURBISHMENT OF OFFICE SPACE AT DINALUNGAN, AURORA
FOR THE USE OF BRANCH 101, REGIONAL TRIAL COURT,
DINALUNGAN, AURORA**

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the refurbishment of Office Space in Dinalungan, Aurora for the use of Branch 101, Regional Trial Court, Dinalungan, Aurora with an Approved Budget for the Contract (ABC) in the amount of **One Million Seven Hundred Seventy-Six Thousand Six Hundred Fifty Pesos and 11/100 (₱1,776,650.11)** chargeable against the amount allotted for Repairs and Maintenance, Government Facilities under General Appropriations Act for FY 2019. The duration for the subject project is for a period of Sixty (60) calendar days.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed, within five (5) years from the date of submission and opening of bids, at least one (1) contract that is similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **Category Small B, Size Range-C & D** for general building.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.
7. A complete set of Bidding Documents may be purchased from **28 September 2020 to 27 October 2020** by interested bidders from the –

9. The Pre-Bid Conference shall be open to all interested parties through video conference via Zoom. The mechanics thereof will be provided in a bid bulletin to be issued before the pre-bid conference.
10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
11. Bids shall be physically submitted in the Supreme Court on or before the given deadline. Late bids shall not be accepted.
12. Bids will be opened in the presence of the bidders, or their representatives, through video conference via Zoom. The mechanics thereof will be provided in a bid bulletin to be issued.
13. The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
