**AMENDED INVITATION TO BID FOR WORKS CONTRACTOR
FOR THE REPAIR AND REHABILITATION OF
VARIOUS HALLS OF JUSTICE**

1. The Invitation to Bid for the Repair and Rehabilitation of the Halls of Justice of Socorro, Oriental Mindoro, Bangui, Ilocos Norte and Balatan, Camarines Sur, among others, was published in a newspaper of general circulation last December 17, 2017. As indicated in the said invitation, the Pre-Bid Conference and the Opening of Bids thereon were set on 4 January 2018 and 16 January 2018, respectively.
2. Considering the decision of the Bids and Awards Committee for the Halls of Justice (BAC-HOJ) to revise the whole timelines of the procurement process for the foregoing projects, there is a need to amend the Invitation to Bid which was previously advertised.
3. Thus, the *Supreme Court of the Philippines*, through the BAC-HOJ, is again inviting interested bidders to participate in the procurement of works contractor for the following projects:

4. Bids received in excess of the ABC shall be automatically rejected at bid opening.
5. Bidders should have completed, at least one (1) contract that is similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
7. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with the following required license categories:



13. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend, at the Conference Room, Office on Halls of Justice, 7th floor, Centennial Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila. Late bids shall not be accepted.

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
