Other contractors not previously deemed eligible by the *Supreme Court of the Philippines* may also apply for eligibility by submitting a letter of intent within the period hereinafter provided.

mentioned herein, the *Supreme Court of the Philippines* shall resolve procurement issues by resorting to and applying the pertinent provisions of R.A. No. 9184 and its Implementing Rules and Regulations.
