**INVITATION TO BID FOR WORKS CONTRACTOR FOR THE REFURBISHMENT OF
THE GROUND FLOOR OF THE HALL OF JUSTICE IN ARGAO, CEBU**

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the refurbishment of the **Hall of Justice in Argao, Cebu** with an Approved Budget for the Contract (ABC) in the amount of **Four Million Four Hundred Eighty-Seven Thousand Two Hundred Fifty-Three Pesos and 23/100 (₱4,487,253.23)**, chargeable against the amount allotted for the Construction/Completion or Repair/Rehabilitation of the Halls of Justice nationwide. The duration for the subject project is for a period of Ninety (90) calendar days.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed at least one (1) contract that is similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II- Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least **category "D", size range Small "B"** for general building.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.


8. The *Supreme Court of the Philippines*, through the BAC-HOJ, will hold the schedule of procurement activities, as follows:

11. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend, at the Office of DCA Raul Bautista Villanueva, 3/F Old Building, Supreme Court of the Philippines, Padre Faura, Ermita, Manila. Late bids shall not be accepted.

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of 2016 Revised RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
