**BIDS AND AWARDS COMMITTEE FOR THE HALLS OF JUSTICE**

**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE CONTRACT OF SECURITY SERVICES FOR THE HALLS OF JUSTICE IN CENTRAL LUZON REGION**

1. The *Supreme Court of the Philippines*, through the *Appropriations for the Maintenance and Other Operating Expenses of the Halls of Justice*, invites bids for the Contract of Security Services for the **Halls of Justice in Central Luzon Region** with an Approved Budget for the Contract (ABC) in the amount of **FORTY-TWO MILLION SEVENTY-SEVEN THOUSAND SIX HUNDRED FORTY PESOS AND 01/100 (₱42,077,640.01)**. The delivery of services is required for a period of **Two (2) Years**.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed within **Five (5) Years** from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC for One (1) Year. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.


8. The *Supreme Court of the Philippines*, through the BAC-HOJ, will hold the schedule of procurement activities, as follows:

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not to award the contract at any time prior to contract award in accordance with Section 41 of 2016 Revised RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
