

(c) **AUTHORIZE** the Fiscal Management and Budget Office to **PAY** Superb Security and Investigation Agency, Inc. the contract amount of Fourteen Million Three Hundred Thirteen Thousand Two Hundred Forty-Eight Pesos and 04/100 (P14,313,248.04); and

(d) **AUTHORIZE** Court Administrator Jose Midas P. Marquez to **SIGN**, for and in behalf of the Court, the

subject security service contract with Superb Security and Investigation Agency, Inc.

The Court likewise Resolved, upon the recommendation of the BAC-HOJ, to

(a) **DECLARE** the bid of APL Security Services Corporation in the amount of Eight Million Six Hundred Ten Thousand Four Hundred Eighty-Two Pesos and 40/100 (P8,610,482.40) as the single calculated responsive bid in the procurement of security services for the Halls of Justice in Region IX;

(b) **AWARD** to **APL Security Services Corporation** the contract for security services in the Halls of Justice in Region IX and the deployment of fifty-eight (58) security guards;

(c) **AUTHORIZE** the Fiscal Management and Budget Office to **PAY** APL Security Services Corporation the contract amount of Eight Million Six Hundred Ten Thousand Four Hundred Eighty-Two Pesos and 40/100 (P8,610,482.40); and

(d) **AUTHORIZE** Court Administrator Jose Midas P. Marquez to **SIGN**, for and in behalf of the Court, the subject security service contract with APL Security Services Corporation." (adv31)
