2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed, at least one (1) contract that is similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least "**Category D**" for general building.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.


