PROCUREMENT OF VARIOUS OFFICE DEVICES FOR LOWER COURTS

The Supreme Court intends to apply, through the **Appropriations of the Lower Courts**, the sum of **Three Million One Hundred Eighty-Four Thousand One Hundred Five Pesos (₱3,184,105.00) inclusive of Value-Added Tax (12%)**, being the Approved Budget for the Contract (ABC), to payments under the contract for the **Procurement of Various Office Devices for Lower Courts [Project]**. Bids received in excess of the ABC shall be automatically rejected at bid opening. The goods are grouped in a single lot, which shall not be divided for purposes of this procurement.

The Supreme Court Bids and Awards Committee for Goods and Services (SC-BAC-GS) now invites bids for the above-stated procurement. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders and Section III, the Bid Data Sheet.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the SC- BAC-GS Secretariat, and inspect the Bidding Documents at the address given below.

A complete set of Bidding Documents may be acquired by interested bidders starting **June 24, 2018, 9:00 a.m. to 4:00 p.m** from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, **in the amount of Three Thousand Pesos (₱3,000.00)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Supreme Court, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The Supreme Court will hold the **Pre-Bid Conference on July 3, 2018, 2:00 p.m. at the OCA Conference Room 1, 3rd Floor, Supreme Court Old Building, Taft Ave., Manila** which shall be open to all interested parties.

Bids must be delivered to the address below **on or before July 17, 2018 at 12:00 noon**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted. Bid opening shall immediately follow at **2:00 p.m. at the OCA Conference Room 1, 3rd Floor, Supreme Court Old Building, Taft Ave., Manila** in the presence of the bidders' representatives who choose to attend at the given address.

The Supreme Court reserves the right to accept or reject any bid, annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
