**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY, DELIVERY AND
INSTALLATION OF FURNITURE AT THE HALL OF JUSTICE IN MANDALUYONG CITY**

1. Pursuant to its Resolution dated June 26, 2018 in A.M. No. 18-06-14-SC, the *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the Supply, Delivery and Installation of Furniture at the Hall of Justice in Mandaluyong City with an Approved Budget for the Contract (ABC) in the amount of Five Million Three Hundred Eight Thousand One Hundred Thirty-Eight Pesos & 88/100 (Php5,308,138.88) to be sourced from the Local Bank Account of the Supreme Court. The period of completion of the said project is ninety (90) calendar days.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.


7. The *Supreme Court of the Philippines*, through the BAC-HOJ, will hold the schedule of procurement activities, as follows:

9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
10. Bids will be opened in the presence of the bidders and/or their representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Supreme Court of the Philippines* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. In instances that may arise and not specifically mentioned herein, the *Supreme Court of the Philippines* shall resolve bidding issues by resorting to and applying the pertinent provisions of R.A. No. 9184 and its Implementing Rules and Regulations.
