**INVITATION TO BID FOR WORKS CONTRACTOR FOR THE CONSTRUCTION OF THE
HALL OF JUSTICE IN NAUJAN, ORIENTAL MINDORO**

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the construction of the **Hall of Justice in Naujan, Oriental Mindoro (Branch 12, Family Court and Municipal Trial Court, both of Naujan, Oriental Mindoro)** with an Approved Budget for the Contract (ABC) in the amount of **Forty-Two Million Four Hundred Seventy-Four Thousand Seven Hundred Thirty-Three Pesos and 46/100, (Php42,474,733.46)**, chargeable against the amount allotted for Locally Funded Projects under the General Appropriations Act FY 2018. The duration for the subject project is for a period of **Three Hundred (300)** calendar days.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Bidders should have completed, at least one (1) contract that is similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least "**Category D**", **Size Range Small "B"** for general building.
6. Interested bidders may obtain further information from the *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from *8:00 in the morning until 4:30 in the afternoon*.
7. A complete set of Bidding Documents may be purchased from **23 October 2019 to 19 November 2019** by interested bidders from the –

10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
11. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend, at the Office of DCA Raul Bautista Villanueva , 3F Old Building, Supreme Court of the Philippines, Padre Faura St., Ermita, Manila. Late bids shall not be accepted.

The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of 2016 revised RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
