**INVITATION TO BID FOR THE PROCUREMENT OF WORKS
CONTRACTOR FOR THE REFURBISHMENT OF A LEASED OFFICE
SPACE FOR THE USE OF THE NEWLY CREATED COURTS
OF CEBU CITY**

1. The *Supreme Court of the Philippines* through the amount allotted for Locally Funded Projects under the General Appropriation Act for FY 2018 (R.A. 10964) intends to apply the total sum of *Twenty Seven Million Six Hundred Fifty Nine Thousand Eight Hundred Sixty Nine Pesos and 37/100 (₱27,659,869.37)* being the Approved Budget for the Contract (ABC) to payments under the contract for *the refurbishment of the 3rd and 4th floors of the Qimonda IT Center, located along Sergio Osmeña Boulevard, Cebu City.* Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Supreme Court of the Philippines* now invites bids for *the refurbishment of the 3rd and 4th floors of the Qimonda IT Center, located along Sergio Osmeña Boulevard, Cebu City.* The said works are required to be completed within a period of *One Hundred Fifty (150) Calendar Days.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”
4. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines and registered with the Philippine Contractors Accreditation Board (PCAB) with license category of at least Small “B” for general building.
5. Interested bidders may obtain further information *Supreme Court of the Philippines* and inspect the Bidding Documents at the address given below from *8:00 a.m. to 4:30 p.m.*
6. A complete set of Bidding Documents may be purchased starting *03 December 2018 to 03 January 2018* by interested Bidders from:



The *Supreme Court of the Philippines* will hold a Pre-Bid Conference on **20 December 2018, 9:30 a.m.** at the *Office of Deputy Court Administrator Raul Bautista Villanueva, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura St., Ermita, Manila*, which shall be open to prospective bidders. The Pre-Bid Conference shall be open to all interested parties.
8. Bids must be duly received by the **BAC Secretariat** on or before **03 January 2018, 9:00 a.m.** at the *Office of Deputy Court Administrator Raul Bautista Villanueva, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura St., Ermita, Manila*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.1.b.
9. Bid opening shall be on **03 January 2018, 9:30 a.m.** to be held also at the *Office of Deputy Court Administrator Raul Bautista Villanueva, 3rd Floor, Old Main Building, Supreme Court of the Philippines, Padre Faura St., Ermita, Manila*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
10. The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


*Please take notice that the Court en banc issued a Resolution dated **OCTOBER 16, 2018**, which reads as follows:*
