**REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTANCY SERVICES FOR THE
DETAILED ARCHITECTURAL AND ENGINEERING DESIGN FOR THE CONSTRUCTION OF
THE HALL OF JUSTICE IN PINAMALAYAN, ORIENTAL MINDORO**

1. The *Supreme Court of the Philippines*, through the Bids and Awards Committee for the Halls of Justice (BAC-HOJ), invites bids for the preparation of the Detailed Architectural and Engineering Design (DAED) for the Construction of the Hall of Justice in Pinamalayan, Oriental Mindoro, with an Approved Budget for the Contract in the amount of **Three Million Forty-Eight Thousand Eight Hundred Ten Thousand Pesos (Php3,048,810.00)**, chargeable against the Local Bank Account of the Supreme Court of the Philippines. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Supreme Court of the Philippines now calls for the submission of eligibility documents for the DAED for the above construction works. Interested consultants must submit one (1) original copy and seven (7) duplicate copies of their eligibility documents on or before 10 January 2019 at 9:00 A.M., at the Office of Deputy Court Administrator Raul Bautista Villanueva, 3rd Floor Old Building, Supreme Court of the Philippines, Padre Faura St., Ermita Manila. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Prospective bidders must have completed within the last five (5) years a contract of similar nature. "Similar nature" shall mean Detailed Architectural and Engineering Design.
5. A complete set of Bidding Documents may be purchased on *17 December 2018 to 10 January 2018* by interested bidders from-

and upon payment of a nonrefundable fee of Five Thousand Pesos (₱5,000.00) for the said consulting services.

6. The BAC shall draw up the short list of consultants from those who have submitted eligibility documents and have been determined as eligible in accordance with the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184. The short list shall consist of a maximum of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are as follows:

<i>Experience of Consultant</i>	50%
<i>Qualification of Personnel (Principal and Key Staff)</i>	30%
<i>Current Workload and Financial Capacity/Networth</i>	20%
<i>Total</i>	100%

The minimum score to qualify for shortlisting shall be *EIGHTY PERCENT (80%)*.

7. A Notice of Eligibility and Shortlisting, indicating therein the schedule for the submission of Technical and Financial Documents, shall be issued.
8. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBS/QCBE)*, Fixed Budget Selection, or Least-Cost Selection] procedure. The technical proposal shall carry 70% weight while the financial proposal shall have 30% weight.
9. The contract shall be completed within a period of One Hundred Twenty (120) days from issuance of the Notice to Proceed and the contract will terminate after the issuance by the Supreme Court of the Philippines and receipt by the Civil Works Contractor of the Final Certificate of Acceptance for the above listed projects.
10. The Supreme Court of the Philippines reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
