**BIDS AND AWARDS COMMITTEE
FOR GOODS AND SERVICES (SC-BAC-GS)**

Resolution No. 2019-30

**RE: AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF EIGHT (8) SHUTTLE BUSES
FOR THE SUPREME COURT**

WHEREAS, the SC-BAC-GS received the 1st Indorsement dated August 20, 2019 from the Procurement Planning Committee relative to the *Procurement of Eight (8) Shuttle Buses for the Supreme Court* with an Approved Budget for the Contract (ABC) in the amount of Sixty Four Million Four Hundred Forty Thousand Pesos (P64,440,000.00), inclusive of Value-Added Tax;

WHEREAS, on the basis of the said Indorsement and after the conduct of the Pre-Procurement Conference on September 3, 2019, the SC-BAC-GS caused the posting of the Invitation to Bid on September 23, 2019 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, six (6) prospective bidders attended the pre-bid conference on October 1, 2019, namely:

1. Durabuilt Motors, Inc.
2. Isuzu Automative Dealership, Inc. (Isuzu Alabang)
3. Golden Asia Automative Builders, Inc.
4. Hino Motors Philippines Corporation
5. Hyundai Alabang, Inc.
6. Hyundai Baliwag

WHEREAS, four (4) bidders purchased the bidding documents and paid the non-refundable fee of Twenty Six Thousand Five Hundred Pesos (P26,500.00) to cover the cost for the preparation of the said bidding documents, namely:

1. Golden Asia Automative Builders, Inc.
2. Durabuilt Motors, Inc.
3. Hino Motors Philippines Corporation
4. Cross Country Motors, Inc.

WHEREAS, on the day of the submission of bids and opening of bids on October 15, 2019, three (3) bidders submitted their respective bids, namely:

Upon evaluation of its eligibility submission, Golden Asia Automative Builders, Inc. was disqualified due to its failure to submit the correct computation of its Net Financial Contracting Capacity. On the other hand, Durabuilt Motors, Inc. was likewise declared disqualified due to its failure to submit the 2019 Mayor's Permit (as the PhilGEPS Certificate of Registration showed that the Mayor's Permit expired on January 13, 2019; the requirement for the submission of the updated documents in case the documents stated in the PhilGEPS Certificate are expired was discussed with the bidders during the Pre-Bid Conference on October 1, 2019) and considering that the Company Profile submitted stating that the date of establishment of the company is only on December 14, 2017, or just almost three (3) years, was found to be non-compliant with the five (5)-year requirement of company existence.

Hino Motors Philippines Corporation was declared eligible and qualified after the opening and evaluation of its Eligibility and Technical submission;

WHEREAS, the SC-BAC-GS explained to the ineligible bidders the reason for their disqualification. Further, the SC-BAC-GS inquired from the ineligible bidders whether they intend to file a motion for reconsideration of their disqualification. The ineligible bidders expressed their decision to file a motion for reconsideration and was given until October 18, 2019 to submit the same;

WHEREAS, the SC-BAC-GS opened the financial bid of Hino Motors Philippines Corporation. The financial bid tendered is Sixty Four Million Four Hundred Thousand Pesos (P64,400,000.00);

WHEREAS, both Golden Asia Automative Builders, Inc. and Durabuilt Motors, Inc. timely filed their respective motions for reconsideration. During the meeting on October 21, 2019, the SC-BAC-GS resolved to deny both the motions for reconsideration with finality. Thus, the financial bid of Hino Motors Philippines Corporation in the amount of Sixty Four Million Four Hundred Thousand Pesos (P64,400,000.00) was declared as the *Single Calculated Bid*, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued on October 21, 2019 to Hino Motors Philippines Corporation which upon its receipt submitted the documents within the prescribed period;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification inspection was conducted by the SC-BAC-GS and the representatives of the end-user on October 24, 2019, which consisted of the ocular inspection of the premises and facilities of Hino Motors Philippines Corporation;


WHEREAS, in its Post-Qualification Report dated October 28, 2019, the post-qualification inspection team found no ground to post-disqualify the bid of Hino Motors Philippines Corporation;



WHEREAS, after review and evaluation of the findings of the post-qualification inspection team on Hino Motors Philippines Corporation's documentary submissions and the ocular inspection of its premises, the SC-BAC-GS is of the view that Hino Motors Philippines Corporation has met the requirements of the Supreme Court and declared its bid as the *Single Calculated and Responsive Bid*;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to recommend the award of the contract for the *Procurement of Eight (8) Shuttle Buses for the Supreme Court* to **HINO MOTORS PHILIPPINES CORPORATION** in the amount of *Sixty Four Million Four Hundred Thousand Pesos (P64,400,000.00) inclusive of Value-Added Tax*.


