**Resolution No. 2019-14**

**RE: AWARD OF THE CONTRACT FOR THE  
PROCUREMENT OF VEHICLES FOR THE USE  
OF VARIOUS OFFICES UNDER THE OFFICE OF  
THE COURT ADMINISTRATOR - LOT 2: THREE  
(3) UNITS OF PASSENGER VAN**

**WHEREAS**, the SC-BAC-GS received the 1<sup>st</sup> Indorsement dated February 28, 2019 from the Procurement Planning Committee relative to the *Procurement of Vehicles for the Use of Various Offices under the Office of the Court Administrator - Lot 2: Three (3) Units of Passenger Van*, with an Approved Budget for the Contract (ABC) in the amount of Six Million Three Hundred Sixty Thousand Pesos (P6,360,000.00), inclusive of Value-Added Tax;

**WHEREAS**, on the basis of the said Indorsement and after the conduct of the Pre-Procurement Conference on March 19, 2019, the SC-BAC-GS caused the posting of the Invitation to Bid on March 25, 2019 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

**WHEREAS**, two (2) prospective bidders, (1) Nissan Commonwealth, Inc. and (2) Nissan Sucat, attended the pre-bid conference on April 2, 2019;

**WHEREAS**, the deadline of submission and opening of bids has been moved to April 15, 2019 due to the lack of quorum on the original schedule on April 16, 2019;

**WHEREAS**, only Nissan Commonwealth, Inc. purchased the bidding documents and paid the non-refundable fee of Seven Thousand Pesos (P7,000.00) to cover the cost for the preparation of the said bidding documents;

**WHEREAS**, on the day of the submission of bids on April 15, 2019, only Nissan Commonwealth, Inc. submitted its bid and was declared eligible and qualified after the opening and evaluation of its Eligibility/Technical and Financial Envelopes;



**WHEREAS**, Nissan Commonwealth, Inc. tendered its financial bid in the amount of *Six Million Three Hundred Fifty-Four Thousand Pesos (P6,354,000.00)* and was declared as the Single Calculated Bid, subject to post-qualification process;

**WHEREAS**, the notice for submission of post-qualification documents was issued on April 24, 2019 to Nissan Commonwealth, Inc. which upon its receipt submitted the documents within the prescribed period;

**WHEREAS**, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification inspection was conducted by the SC-BAC-GS and the representative of the end-user on May 8, 2019, which consisted of the ocular inspection of the premises and facilities of Nissan Commonwealth, Inc.;

**WHEREAS**, in its Post-Qualification Report dated May 23, 2019, the post-qualification inspection team found no ground to post-disqualify the bid of Nissan Commonwealth, Inc.;

**WHEREAS**, after review and evaluation of the findings of the post-qualification inspection team on Nissan Commonwealth, Inc.'s documentary submissions and the ocular inspection of its premises, the SC-BAC-GS is of the view that Nissan Commonwealth, Inc. has met the requirements of the Supreme Court and declared its bid as the Single Calculated and Responsive Bid;

**NOW THEREFORE**, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to recommend the award of the contract for the *Supply and Delivery of Vehicles for the Use of Various Offices under the Office of the Court Administrator - Lot 2: Three (3) Units of Passenger Van* to **NISSAN COMMONWEALTH, INC.** in the amount of **Six Million Three Hundred Fifty-Four Thousand Pesos (P6,354,000.00)**, inclusive of Value Added Tax (VAT).
