*Please take notice that the Court, Second Division, issued a Resolution dated **23 February 2022** which reads as follows:*

“A.C. No. 11569 (Atty. Ron P. Salo v. Atty. Herminio “Harry” L. Roque, Jr., Atty. Joel R. Butuyan, and Atty. Romel R. Bagares). – The Court **NOTES** the letter¹ dated January 19, 2021 of Atty. Randall C. Tabayoyong, Director for Bar Discipline, Integrated Bar of the Philippines, Commission on Bar Discipline, transmitting the documents pertaining to this case.

The Court further **NOTES** the Notice of Resolution² dated December 15, 2019 of the Integrated Bar of the Philippines (IBP) Board of Governors which adopted and approved the Investigating Commissioner’s Report³ recommending the dismissal of the complaint against Atty. Herminio “Harry” L. Roque, Jr., Atty. Joel R. Butuyan, and Atty. Romel R. Bagares, for lack of merit.
