
*Please take notice that the Court, Second Division, issued a Resolution dated **June 27, 2022** which reads as follows:*

“**A.C. No. 11921 [Formerly CBD Case No. 18-5840] (Rodrigo M. Sicutad v. Atty. Consuelo B. Tarampi-Taccad).** – The Court **NOTES** the Notice of Resolution No. CBD-XXV-2021-09-42¹ dated September 25, 2021 of the Integrated Bar of the Philippines (IBP) Board of Governors which resolved to approve and adopt the Report and Recommendation² of the Investigating Commissioner dated October 7, 2019 to dismiss the complaint against respondent Atty. Consuelo B. Tarampi-Taccad (respondent) for lack of merit; transmitted by letter dated January 31, 2022 of Director Avelino V.
