
*Please take notice that the Court, Second Division, issued a Resolution dated **July 4, 2022** which reads as follows:*

Dacalos, Jr.)**. — The Court **NOTES** the Notice of Resolution in CBD Case No. 15-4689¹ dated May 30, 2020 of the Integrated Bar of the Philippines (IBP) Board of Governors which adopted the Report and Recommendation² dated December 5, 2019 of the Investigating Commissioner to dismiss the case; transmitted by letter dated April 28, 2021 of Director Randall C.
