“A.C. No. 13331 (*Anita Shearer v. Atty. Dennis Aldrich C. Del Rosario*). – This Court **NOTES** the Notice of Resolution No. CBD-XXV-2021-09-17 dated September 11, 2021 of the Integrated Bar of the Philippines (IBP) Board of Governors which dismissed the instant complaint for lack of jurisdiction consistent with this Court’s decision in the case, “Sps. Edwin B. Buffe and Karen M. Silverio-Buffe v. Sec. Raul M.
