
*Please take notice that the Court, Second Division, issued a Resolution dated **August 3, 2022** which reads as follows:*

**“OCA IPI No. 20-5036-P (Modesto P. Fermin, complainant v. Angelica C. Gatchalian, Contractual Court Stenographer III, Regional Trial Court, Branch 97, Quezon City, respondent.)** – The Court **NOTES** the (1) letter-complaint dated March 13, 2020 of Modesto P. Fermin, a driver-courier of the Quezon City Postal Office, against Angelica C. Gatchalian, a contractual Court Stenographer III assigned in the Regional Trial Court (RTC), Branch 97, Quezon City for misconduct; and (2) comment dated December 15, 2020 of respondent Angelica C. Gatchalian denying the allegations of the complainant.

The Report dated May 25, 2022 of the Judicial Integrity Board is **NOTED**. The Court resolves to **ADOPT** and **APPROVE** the findings of fact, conclusions of law, and recommendations of the Judicial Integrity Board in the attached Report dated May 25, 2022.
