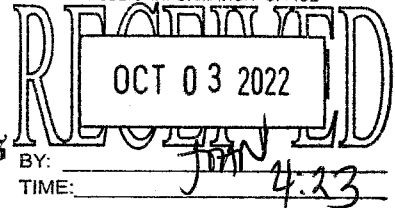

Sirs/Mesdames:

*Please take notice that the Court en banc issued a Resolution dated **SEPTEMBER 27, 2022**, which reads as follows:*

“**G.R. No. 261892** (Kilusan sa Pagbabago ng Industriya ng Transportasyon, Inc. [KAPIT], et al. vs. City of Manila, et al.) and **G.R. No. 262192** (Atty. Juman B. Paa vs. Sangguniang Panglungsod ng Manila and Hon. Dr. Maria Sheilah Lacuna-Pangan).- The Court Resolved to

(a) **SET** these cases for **PRELIMINARY CONFERENCE** on **November 4, 2022**, at **2:00 in the afternoon**, at the New Session Hall, New Supreme Court Building, Padre Faura Street, Ermita, Manila; and

(b) **RESCHEDULE** the Oral Arguments to **December 6, 2022**, at **2:00 in the afternoon**, same venue.

The Court further Resolved to


(a) **NOTE** the Comment (on the Petition) dated August 25, 2022 filed by the Office of the Solicitor General for respondent Land Transportation Office in G.R. No. 261892 in compliance with the resolution dated August 9, 2022;

(b) **NOTE** the Comment/Opposition (Re: Manifestation and Motion dated September 12, 2022), dated September 21, 2022 filed by counsel for petitioners in G.R. No. 261892, stating that the petition and the Makati City Petition for Injunction shows that there is no identity of parties, facts or issues; and praying that the Manifestation and Motion dated September 12, 2022 filed by respondent Land Transportation Office be denied for utter lack of merit; and

(c) **REQUIRE** the Metropolitan Manila Development Authority (MMDA) to file a **CONSOLIDATED COMMENT** on the petitions within ten (10) days from notice hereof.
