Bersamin).- Acting on the Petition for *Certiorari* and Prohibition (with Extremely Urgent Prayer for the Issuance of Temporary Restraining Order and/or Writ of Preliminary Mandatory Injunction and for the Conduct of a Special Raffle of this Case), the Court Resolved, without giving due course to the petition, to
