

ANNOUNCEMENT

In the Announcement dated 13 January 2021, which was published in two newspapers of general circulation and posted on the website of the Judicial and Bar Council (JBC), the position of *Deputy Ombudsman for Mindanao (DOM* - vice Hon. **Rodolfo M. Elman**, whose term of office will end on 13 March 2021) was announced open for acceptance of applicants and other documentary requirements within the period **14 January 2021 - 1 March 2021**.

Recently, the JBC received a request from the Office of the Ombudsman for the extension of the deadline for the submission of application documents for the said position. Acting thereon, the JBC agreed to extend the deadline for submission of application documents from 1 March 2021 to 30 March 2021. Interested applicants must visit the official JBC website (jbc.judiciary.gov.ph/) and access the Online Application Scheduler not later than 30 March 2021 (Tuesday), from 8:00 a.m. to 12:00 midnight.

Interested applicants must visit the official **JBC** website (jbc.judiciary.gov.ph/) and access the Online Application Scheduler between 8:00 a.m. and 12:00 midnight, not later than the non-extendable deadline of 29 April 2021 (Thursday). After filling in the required information in the Online Application Scheduler, they will receive a computer-generated letter of intent in their e-mail addresses. They must submit the complete and accurate digitized versions of (a) the letter of intent and (b) the documentary requirements through electronic mail to orsn.jbc@judiciary.gov.ph on their selected date and time of appointment in the Online Application Scheduler. The date of actual receipt of the complete documentary requirements (sent through e-mail) shall be deemed as the date of filing. In addition, the applicants shall ensure receipt by the JBC of two (2) complete sets of the hard copies of the documentary requirements through courier service not later than 4:30 p.m. of the abovementioned non-extendable deadline. Applicants who fail to comply with the requirements of online and physical submission via courier service of the documentary requirements shall not be considered for nomination.  - ☐ Clearance/Certification of pending and past cases issued by the OBC (*Note: not required of Justices and Judges*)
 - ☐ Clearance/Certification of pending and past cases issued by the IBP National Office
 - □ NBI Clearance
 - ☐ Ombudsman Clearance
 - □ National Police Clearance

It must be noted that the qualification of applicants shall be reckoned as of the deadline for filing of applications. For the qualification requirements and evaluative criteria (such as the completion by non-judge applicants for judicial posts of the Prejudicature Program with a passing grade in the written evaluative exercise as prescribed under Section 3, Rule 3 of the 2020 Revised JBC Rules pursuant to Section 10, Republic Act No. 8557), please refer to the 2020 Revised JBC Rules in the JBC website.

Applicants who have been found by the Council to have wilfully made false statements, misrepresentations, or concealments of any material information as provided for under the 2020 Revised JBC Rules shall be considered disqualified from being nominated by the Council.
