BIDS AND AWARDS COMMITTEE FOR GOODS AND SERVICES (SC-BAC-GS)

Resolution No. 2022-03

RE: AWARD OF THE CONTRACT FOR THE PROCUREMENT OF THREE (3) UNITS OF MOTOR VEHICLES FOR THE OFFICIAL USE OF THE SUPREME COURT (RE-BIDDING)

WHEREAS, the Court, in its Resolution dated November 9, 2021 in A.M. No. 21-02-16-SC (Re: Procurement of Three (3) Units of Motor Vehicles for the Official Use of the Supreme Court), authorized the SC-BAC-GS to conduct a rebidding for the Procurement of Three (3) Units of Motor Vehicles for the Official Use of the Supreme Court with an Approved Budget for the Contract (ABC) in the amount of Six Million Six Hundred Seventy Two Thousand Pesos (₱6,672,000.00) inclusive of Value-Added Tax;

WHEREAS, on the basis of the said authority, after the conduct of the Pre-Procurement Conference on November 23, 2021, and the finalization of the bidding documents, the SC-BAC-GS caused the posting of the Invitation to Bid on November 29, 2021 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, only B. M. Domingo Motor Sales Inc. and its representative attended the Pre-Bid Conference on December 7, 2021;

WHEREAS, only B. M. Domingo Motor Sales Inc. purchased the bidding documents and paid the non-refundable fee of Six Thousand Five Hundred Pesos (₱6,500.00) to cover the cost for the preparation of the bidding documents;

WHEREAS, B. M. Domingo Motor Sales Inc. submitted its bid within the deadline set on December 21, 2021. During the opening of bids conducted on the same date, the following are the results of the evaluation bids:

WHEREAS, with an ABC in the amount of Six Million Six Hundred Seventy Two Thousand Pesos (₱6,672,000.00) inclusive of Value-Added Tax, and after passing the detailed technical evaluation conducted by the implementing office, the financial bid of B. M. Domingo Motor Sales Inc. in the amount of Six Million Six Hundred Sixty Nine Thousand Pesos (₱6,669,00.00) was declared by the Committee as the Single Calculated Bid, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to B. M. Domingo Motor Sales Inc. on January 18, 2022, which upon its receipt submitted the documents on within the reglementary period;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS on the basis of documentary submissions, as conformed by the end-user representative / implementing office, the Property Division, Office of Administrative Services, Supreme Court. The Post-Qualification Report on B. M. Domingo Motor Sales Inc. dated February 10, 2022 was submitted to the SC-BAC-GS for its consideration;

WHEREAS, after review and evaluation of the findings of the post-qualification team on B. M. Domingo Motor Sales Inc.'s documentary submissions, the SC-BAC-GS is of the view that B. M. Domingo Motor Sales Inc. has met the requirements of the Supreme Court and declared its bid as the *Single Calculated and Responsive Bid*;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:

- 1. RECOMMEND the <u>AWARD</u> of the contract for the *Procurement* of Three (3) Units of Motor Vehicles for the Official Use of the Supreme Court (re-bidding) to <u>B. M. DOMINGO MOTOR SALES INC.</u> in the amount of SIX MILLION SIX HUNDRED SIXTY NINE THOUSAND PESOS (\$\mathbb{P}6,669,00.00), inclusive of Value-Added Tax; and
- 2. request that ATTY. MARIFE M. LOMIBAO-CUEVAS, Clerk of Court, Supreme Court, be authorized to sign, for and in behalf of the Court, the contract with <u>B. M. DOMINGO MOTOR SALES INC.</u>
