Resolution No. 2022-02

RE: AWARD OF THE CONTRACT FOR THE PROCUREMENT OF AIR CONDITIONING UNITS FOR VARIOUS OFFICES OF THE SUPREME COURT

WHEREAS, the SC-BAC-GS received the 4th Indorsement dated November 10, 2021 from the Procurement Planning Committee relative to the *Procurement of Air Conditioning Units for Various Offices of the Supreme Court* with an Approved Budget for the Contract (ABC) in the amount of One Million Six Hundred Twenty Thousand Pesos (₱1,620,000.00), inclusive of Value-Added Tax;

WHEREAS, on the basis of the said indorsement, after the conduct of the Pre-Procurement Conference on November 23, 2021, and the finalization of the bidding documents, the SC-BAC-GS caused the posting of the Invitation to Bid on November 29, 2021 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, ten (10) prospective bidders and their representatives attended the Pre-Bid Conference on December 7, 2021, namely:

WHEREAS, three (3) prospective bidders purchased the bidding documents and paid the non-refundable fee of Two Thousand Pesos (₱2,000.00) to cover the cost for the preparation of the bidding documents, namely:

WHEREAS, three (3) prospective bidders submitted their respective bids within the deadline set on December 21, 2021. During the opening of bids conducted on the same date, the following were the results of the evaluation bids:

Temprite Engineering, Inc. failed due to its incomplete submission of the Omnibus Sworn Statement, particularly the original copy of the 3rd page of the statement. In addition, the constant factor 10 was used in its computation of the Net Financial Contracting Capacity, instead of the constant factor 15. Thus, the SC-BAC-GS resolved to disqualify Temprite Engineering, Inc.;

WHEREAS, no motion for reconsideration of its disqualification was filed by Temprite Engineering, Inc.;

WHEREAS, with an ABC in the amount of One Million Six Hundred Twenty Thousand Pesos (₱1,620,000.00), and after passing the detailed technical evaluation conducted by the implementing office, the bid of Aequus Enterprises in the amount of One Million One Hundred Eighty Nine Thousand Nine Hundred Sixty Pesos (₱1,189,960.00) was declared as the *Lowest Calculated Bid*, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to Aequus Enterprises on January 17, 2022, which upon its receipt submitted the documents on within the reglementary period;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS on the basis of documentary submissions, as conformed by the end-user representative / implementing office, Maintenance Division, Office of Administrative Services, Supreme Court. The Post-Qualification Report on Aequus Enterprises dated February 3, 2022 was submitted to the SC-BAC-GS for its consideration;

WHEREAS, after review and evaluation of the findings of the post-qualification team on Aequus Enterprises' documentary submissions, the SC-BAC-GS is of the view that Aequus Enterprises has met the requirements of the Supreme Court and declared its bid as the *Lowest Calculated and Responsive Bid*;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:

- 1. RECOMMEND the AWARD of the contract for the Procurement of Air Conditioning Units for Various Offices of the Supreme Court to AEQUUS ENTERPRISES in the amount of One Million One Hundred Eighty Nine Thousand Nine Hundred Sixty Pesos (₱1,189,960.00), inclusive of Value-Added Tax; and
- 2. request that ATTY. MARIFE M. LOMIBAO-CUEVAS, Clerk of Court, Supreme Court, be authorized to sign, for and in behalf of the Court, the contract with AEQUUS ENTERPRISES.
