**INVITATION FOR PROCUREMENT OF WORKS CONTRACTOR FOR THE  
REFURBISHMENT OF COURT OF APPEALS BUILDING FOR THE  
NEWLY-CREATED REGIONAL TRIAL COURT BRANCHES 78 AND 79,  
AND MUNICIPAL TRIAL COURT IN CITIES BRANCHES 5 AND 6,  
ALL OF BAGUIO CITY**

1. The *Supreme Court of the Philippines*, through the amount allotted for the *Repairs and Maintenance under the General Appropriations Act for FY 2022 (R.A. 11639)*, intends to apply the sum of *Eleven Million Six Hundred Thirty-Five Thousand Four Hundred Seventy-Two Pesos (₱11,635,472.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Refurbishment of Court of Appeals Building for the Newly-Created Regional Trial Court Branches 78 and 79, and Municipal Trial Court in Cities Branches 5 and 6, all of Baguio City*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Supreme Court of the Philippines* now invites bids for the above Procurement Project. Completion of the Works is required for a period of *One Hundred Ten (110) calendar days from Day One (1)*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the Supreme Court of the Philippines and inspect the Bidding Documents at the address given below from 8:00 in the morning until 4:30 in the afternoon.

A complete set of Bidding Documents may be acquired by interested bidders from the abovementioned given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of *Twenty-Five Thousand Pesos (₱25,000.00)*. The prospective bidders shall, before purchasing the Bidding Documents, coordinate with the Secretariat so they may be assisted in making their payments to the Cashier Division, Fiscal Management and Budget Office, Supreme Court. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The *Supreme Court of the Philippines* will hold a *Pre-Bid Conference on November 22, 2022 (Tuesday), 9:30 a.m. through video conferencing/webcasting via Zoom*, which shall

be open to prospective bidders. The Zoom ID and password shall be provided to the interested bidders prior to the Pre-Bid Conference.

7. Bids must be duly received by the Secretariat through manual submission at the Office of the Deputy Court Administrator for Luzon, 3<sup>rd</sup> Floor, Old Building, Supreme Court, Padre Faura St., Ermita, Manila on or before ***December 6, 2022, Tuesday, 9:00 a.m.*** The prospective bidders are advised to coordinate with the Secretariat the expected date and time of the submission of their Bid Documents so they may be properly assisted. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on ***December 6, 2022, Tuesday, 9:30 a.m.*** at the Office of the Deputy Court Administrator for Luzon, 3<sup>rd</sup> Floor, Old Building, Supreme Court, Padre Faura St., Ermita, Manila. Bids will be opened in the presence of the bidders' representatives through videoconferencing via Zoom.

The ***Supreme Court of the Philippines*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
