
Dear Mr. Matias:

Please take notice that the Court en banc issued a Resolution dated NOVEMBER 16, 2021, which reads as follows:


"A.M. No. 19-10-17-SC (Re: Proposed Refurbishment of the Sunvar Realty Building [Leased Property] for the Use of the Newly-Created Courts of Makati City).- The Court Resolved, upon the recommendation of the Bids and Awards Committee for the Halls of Justice, to

(a) **AWARD** to **E.B. Matias Construction and Trading** the contract for the refurbishment of the leased property of Zya Holdings Corporation located at 911 J.P. Rizal Avenue, Brgy.
