
Dear Engr. Avanzado:

Please be informed that the Supreme Court *En Banc*, in its Resolution dated 9 November 2021 in A.M. No. 21-02-05-SC, approved the recommendation of the Bids and Awards Committee for the Halls of Justice to award the Contract for the Construction of the Hall of Justice Building of Sta. 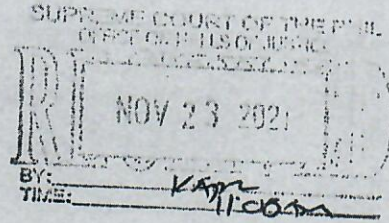

Please take notice that the Court en banc issued a Resolution dated **NOVEMBER 9, 2021**, which reads as follows:


"A.M. No. 21-02-05-SC (Re: Proposed Construction of the Hall of Justice Building of Sta. Rita, Pampanga).- The Court Resolved, upon the recommendation of the Bids and Awards Committee for the Halls of Justice, to

(a) **AWARD** to **MORE Construction** the contract for the construction of the Hall of Justice Building in Sta. Rita, Pampanga in the amount of Six Million Seven Hundred Fifty-Five Thousand Sixteen Pesos and Twenty-Five Centavos (P6,755,016.25);

(b) **AUTHORIZE** the Fiscal Management and Budget Office to **PAY MORE Construction** the aforesaid contract price; and

(c) **AUTHORIZE** the Court Administrator to (i) **SIGN**, for and on behalf of the Court, the contract with **MORE Construction** relative to the subject project and (ii) **APPROVE** related billings arising therefrom." (adv48)
