**Resolution No. 2021-20**

**RE: AWARD OF THE CONTRACT FOR THE  
PROCUREMENT OF SERVICE VEHICLES FOR  
THE OFFICIAL USE OF ASSOCIATE JUSTICES  
OF THE SUPREME COURT - LOT 1: ONE (1) UNIT  
OF SEDAN**

**WHEREAS**, the SC-BAC-GS received the 1<sup>st</sup> Indorsement dated 15 February 2021 from the Procurement Planning Committee relative to the *Procurement of Service Vehicles for the Official Use of Associate Justices of the Supreme Court - Lot 1: One (1) Unit of Sedan* with an Approved Budget for the Contract (ABC) in the amount of Two Million Eight Hundred Thousand Pesos (₱2,800,000.00) inclusive of Value-Added Tax;

**WHEREAS**, on the basis of the said resolution, after the conduct of the Pre-Procurement Conference on 09 March 2021, re-opening of the Supreme Court and the finalization of the technical specifications, the SC-BAC-GS caused the posting of the Invitation to Bid on 07 June 2021 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

**WHEREAS**, three (3) prospective bidders and their representatives attended the Pre-Bid Conference on 15 June 2021, namely:

Toyota Global City, Inc.
Toyota Quezon Avenue
Toyota Balintawak, Inc.

**WHEREAS**, Toyota Global City, Inc. and Toyota Balintawak, Inc. purchased the bidding documents and paid the non-refundable fee of Three Thousand Pesos (₱3,000.00) to cover the cost for the preparation of the bidding documents;





**WHEREAS**, on 28 June 2021, the day of the deadline of submission of bids, both Toyota Global City, Inc. and Toyota Balintawak, Inc. submitted its bid on time;

**WHEREAS**, the opening of bids was conducted on 29 June 2021. The result of the evaluation on both bidders' eligibility, technical and financial requirements are as follows:

Toyota Balintawak, Inc.	FAILED	-

Toyota Balintawak, Inc. was disqualified for its failure to submit the 2020 Audited Financial Statements and its non-compliance to the required computation of the Net Financial Contracting Capacity requirement. The representative of Toyota Balintawak, Inc. informed the SC-BAC-GS that the company will not file a Motion for Reconsideration of its disqualification. The SC-BAC-GS noted the same;

**WHEREAS**, the financial bid of Toyota Global City, Inc. in the amount of Two Million Fifty Two Thousand Eight Hundred Forty Eight Pesos (₱2,052,848.00) was declared by the SC-BAC-GS as the *Single Calculated Bid*, subject to the post-qualification process;

**WHEREAS**, the notice for submission of post-qualification documents was issued to Toyota Global City, Inc., which upon its receipt submitted the documents within the reglementary period;

**WHEREAS**, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS and the representative of the end-user on the basis of its documentary submissions. The Post-Qualification Report on Toyota Global City, Inc. dated 12 July 2021 was submitted to the SC-BAC-GS for its consideration;


**WHEREAS**, after review and evaluation of the findings of the post-qualification team on Toyota Global City, Inc.'s documentary submissions, the SC-BAC-GS is of the view that Toyota Global City, Inc. has met the requirements of the Supreme Court and declared its bid as the *Single Calculated and Responsive Bid*;



**NOW THEREFORE**, We, the members of the SC-BAC-GS, hereby **RESOLVE** as it is hereby **RESOLVED** to:


1. recommend the award of the contract for the *Procurement of Service Vehicles for the Official Use of Associate Justices of the Supreme Court - Lot 1: One (1) Unit of Sedan* to **TOYOTA GLOBAL CITY, INC.** in the amount of **TWO MILLION FIFTY TWO THOUSAND EIGHT HUNDRED FORTY EIGHT PESOS (₱2,052,848.00), INCLUSIVE OF VALUE-ADDED TAX;** and
2. request that **ATTY. MARIFE M. LOMIBAO-CUEVAS**, Clerk of Court, Supreme Court, be authorized to sign, for and in behalf of the Court, the contract with the winning bidder.


