BIDS AND AWARDS COMMITTEE FOR GOODS AND SERVICES (SC-BAC-GS)

Resolution No. 2021-32

RE: AWARD OF THE CONTRACT FOR THE PROCUREMENT OF COMPREHENSIVE HEALTH CARE PLAN TO ALL LOWER COURTS JUDGES OF 1ST AND 2ND LEVEL INCLUDING SHARI'A COURTS

WHEREAS, the Court, in its Resolution dated 15 June 2021, authorized the SC-BAC-GS to conduct a new public bidding for the *Procurement of Comprehensive Health Care Plan to All Lower Courts Judges of 1st and 2nd Level including Shari'a Courts* under the new Terms of Reference, with an Approved Budget for the Contract in the amount of Fifty Seven Million Pesos (₱57,000,000.00), inclusive of Value-Added Tax;

WHEREAS, on the basis of the said resolution, the conduct of the Pre-Procurement Conference on 06 July 2021, the finalization of the bidding documents and the scheduling of procurement activities, the SC-BAC-GS caused the posting of the Invitation to Bid on 23 August 2021 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, two (2) prospective bidders and their representatives attended the Pre-Bid Conference on 31 August 2021, namely:

COCOLIFE
Kaiser International Healthgroup, Inc.

Both purchased the bidding documents and paid the non-refundable fee of Twenty Six Thousand Pesos (\$\mathbb{P}26,000.00)\$ to cover the cost of the preparation of the bidding documents;

WHEREAS, only Kaiser International Healthgroup, Inc. submitted its bid within the deadline set;

WHEREAS, the following were the results of the of the evaluation on Kaiser International Healthgroup, Inc.'s eligibility, technical and financial requirements during the opening of bids on 14 September 2021:

WHEREAS, the detailed technical evaluation was conducted by the heads / representatives of the different Judges' Associations. On 22 September 2021, Judge Sheryll C. Dolendo-Tulabing, the designated Judges' Association representative, informed the Committee that they found Kaiser International Healthgroup, Inc.'s technical proposal compliant with the required technical specifications;

WHEREAS, the financial bid of Kaiser International Healthgroup, Inc. in the amount of *Fifty Five Million Six Hundred Eighty Thousand Pesos* (₱55,680,000.00) was declared by the SC-BAC-GS as the Single Calculated Bid, subject to the postqualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to Kaiser International Healthgroup, Inc. on 22 September 2021, which upon its receipt submitted the documents on 23 September 2021;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, postqualification was conducted by the SC-BAC-GS and the designated representative of Judges' Associations, on the basis of its documentary submissions. The Post-Oualification Report on Kaiser International Healthgroup, 27 September 2021 was submitted to the SC-BAC-GS for its consideration;

WHEREAS, after review and evaluation of the findings of the post-qualification team on Kaiser International Healthgroup, Inc.'s documentary submissions, the SC-BAC-GS is of the view that Kaiser International Healthgroup, Inc. has met the requirements of the Supreme Court and declared its bid as the Single Calculated and Responsive Bid;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:

1. recommend the AWARD of the contract for the Procurement of Comprehensive Health Care Plan to All Lower Courts Judges of 1st and 2nd Level including Shari'a Courts to KAISER INTERNATIONAL HEALTHGROUP, INC. in the amount of FIVE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (\$\overline{P}55,680,000.00)\$, inclusive of Value-Added Tax; and
