BIDS AND AWARDS COMMITTEE FOR GOODS AND SERVICES (SC-BAC-GS)

Resolution No. 2021-39

RE: AWARD OF THE CONTRACT FOR THE PROCUREMENT OF SERVICE PROVIDER FOR THE PRINTING OF THE 2022 COURT CALENDAR

WHEREAS, the SC-BAC-GS received the 1st Indorsement dated September 16, 2021 from the Procurement Planning Committee relative to the Procurement of Service Provider for the Printing of the 2022 Court Calendar with an Approved Budget for the Contract (ABC) in the amount of One Million Six Hundred Forty Eight Thousand Pesos (\$\mathbb{P}\$1,648,000.00), inclusive of taxes;

WHEREAS, on the basis of the said indorsement, after the conduct of the Pre-Procurement Conference on October 5, 2021, and the finalization of the bidding documents, the SC-BAC-GS caused the posting of the Invitation to Bid on October 11, 2021 on the Philippine Government Electronic Procurement Service (PHILGEPS), the Supreme Court website and the bulletin boards within the Supreme Court premises;

WHEREAS, four (4) prospective bidders and their representatives attended the Pre-Bid Conference on October 19, 2021, namely:

Transprint Corporation
Mega-Jesta Prints, Inc.
Innovation Printshoppe Inc.
Pinwheel Media Group Inc.

WHEREAS, three (3) prospective bidders purchased the bidding documents and paid the non-refundable fee of Two Thousand Pesos (₱2,000.00) to cover the cost for the preparation of the bidding documents, namely:

Transprint Corporation
Pinwheel Media Group Inc.
Innovation Printshoppe Inc.

WHEREAS, two (2) prospective bidders submitted its bid within the deadline set, namely:

Transprint Corporation	
Innovation Printshoppe Inc.	

WHEREAS, during the opening of bids conducted on November 3, 2021, both bidders passed in its submission of the eligibility and technical components.

The financial offers were as follows:

Transprint Corporation	₱1,349,040.00
Innovation Printeshoppe Inc.	₱1,623,200.00

WHEREAS, with an ABC in the amount of One Million Six Hundred Forty Eight Thousand Pesos (₱1,648,000.00), inclusive of taxes, and after passing the detailed technical evaluation conducted by the implementing office, the bid of Transprint Corporation in the amount of One Million Three Hundred Forty Nine Thousand Forty Pesos (₱1,349,040.00) was declared as the *Lowest Calculated Bid*, subject to post-qualification process;

WHEREAS, the notice for submission of post-qualification documents was issued to Transprint Corporation on November 8, 2021, which upon its receipt submitted the documents within the reglementary period;

WHEREAS, to verify, validate, ascertain the genuineness, validity, accuracy, and determine the responsiveness of the bid based on the documents submitted, post-qualification was conducted by the SC-BAC-GS on the basis of its documentary submissions, as conformed by the representative of the Supreme Court Public Information Office. The Post-Qualification Report on Transprint Corporation dated November 15, 2021 was submitted to the SC-BAC-GS for its consideration;

WHEREAS, after review and evaluation of the findings of the post-qualification team on Transprint Corporation's documentary submissions, the SC-BAC-GS is of the view that Transprint Corporation has met the requirements of the Supreme Court and declared its bid as the *Lowest Calculated and Responsive Bid*;

NOW THEREFORE, We, the members of the SC-BAC-GS, hereby RESOLVE as it is hereby RESOLVED to:

- 1. **RECOMMEND** the **AWARD** of the contract for the Procurement of Service Provider for the Printing of the 2022 Court Calendar to **TRANSPRINT CORPORATION** in the amount of **ONE MILLION THREE HUNDRED FORTY NINE THOUSAND FORTY PESOS** (₱1,349,040.00), inclusive of taxes; and
- 2. request that ATTY. MARIFE M. LOMIBAO-CUEVAS, Clerk of Court, Supreme Court, be authorized to sign, for and in behalf of the Court, the contract with TRANSPRINT CORPORATION.
