EX-PARTE COMPLIANCE

Petitioners ANTONIO T. CARPIO, ET AL. ("Petitioners"), through the undersigned counsel, respectfully state:

1. In their respective *Verification and Certification Against Non-Forum Shopping* dated 16 July 2020 ("*Verification and Certification*"), Petitioners undertook, pursuant to Rule 7, Section 5(c) of the Rules of Court,¹ to report to the Honorable Court within five (5) days from notice that an action or petition similar to the instant *Petition* has been filed or is pending before a court.

2. For purposes of good faith compliance with the rules, Petitioner Theodore O. Te discloses for the record that, as counsel for petitioners therein, he caused the electronic filing with the Honorable Court on 22 July 2020, the petition in *Doyo, et al. v. Medialdea, et al.*, which was docketed as G.R. No. 252741.

3. On 23 July 2020, Petitioners learned through a news report that the Honorable Court, through its Public Information Office Chief Brian Keith Hosaka, had publicly released a list of petitions filed before the Honorable Court assailing the constitutionality of Republic Act


