***Request for Expression of Interest for
Development Services using Outsystems Low Code Platform***

1. The *Supreme Court of the Philippines*, through funds chargeable against the Local Bank Account of the Supreme Court, earmarked and set aside for the Computerization Program (EISP), pursuant to the Resolution dated 27 September 2016, in *A. M. No. 14-03-06-SC*, intends to apply the sum of **Twenty Five Million Five Hundred Thousand Pesos (₱25,500,000.00)**, being the Approved Budget for the Contract (ABC) for the procurement of *Development Services using Outsystems Low Code Platform*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Supreme Court of the Philippines* now calls for the submission of eligibility documents for *Development Services using Outsystems Low Code Platform*. The primary objective of the engagement is to augment the in-house developers of the Supreme Court of the Philippines - Management Information Systems Office (SC-MISO) with a team of Outsystems platform software professionals in developing applications and related services.

The secondary objective is to provide mentoring services to the SC-MISO development team to further improve their development skills and gain experience using the Outsystems platform.
3. The *Supreme Court Bids and Awards Committee for Consultancy Services (SC BAC CS)* now calls for the submission of eligibility documents for the procurement of the *Development Services using Outsystems Low Code Platform*. Eligibility documents of interested consultants must be duly received by the SC BAC CS Secretariat on or before **15 December 2022 at 10:00 am** at the address indicated below. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
4. Interested bidders may obtain further information from the SC BAC CS Secretariat, and inspect the Bidding Documents at the address given below between 8:00AM and 4:30PM on Mondays to Fridays, excluding holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **05 December 2022** from the address below upon payment of a fee of Twenty-Five Thousand Pesos (₱25,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,

provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The SC BAC CS shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of **a maximum of 5** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Shortlisting Criteria	
Qualifications of the Consultancy Firm	100 POINTS
1. Years of experience in providing Information Technology (IT) workforce services: a. More than 9 years: 50 pts. b. More than 7 years to 9 years: 40 pts. c. 5 years to 7 years: 35 pts.	50
2. Number of completed projects using OutSystem Low Code Platform: a. More than 3 projects: 50 pts. b. 2 to 3 projects: 40 pts. c. 1 project: 35 pts.	50

The minimum score to qualify for shortlisting shall be **SEVENTY PER CENT (70%)**.

7. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

8. The SC BAC CS shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)*. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
9. The contract duration is twelve (12) months.
10. The *Supreme Court of the Philippines* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
