*Please take notice that the Court, Third Division, issued a Resolution dated July 27, 2022, which reads as follows:*

“A.C. No. 13421 [Formerly CBD Case No. 18-5863] (*Azalea D. Hidalgo v. Atty. Reynaldo V. Dulay*). – The Court NOTES the Notice of Resolution No. CBD-2021-05-27<sup>1</sup> dated May 22, 2021 of the Integrated Bar of the Philippines (IBP) Board of Governors which adopted the findings of fact and recommendation<sup>2</sup> of the Investigating Commissioner dated March 31, 2020 and dismissed the complaint for lack of merit, as well as the Notice of Resolution No. CBD-XXV-2022-01-06<sup>3</sup> dated January 22, 2022 which denied the motion for reconsideration filed by complainant Azalea D. Hidalgo, transmitted by letter dated March 30, 2022 of Director Avelino V. Sales, Jr., IBP Commission on Bar Discipline, together with the records of the case and flash drive file.<sup>4</sup> Likewise, the Court resolves to **ADOPT** and **APPROVE** the same. In view thereof, the complaint against Atty. Reynaldo V. Dulay is **DISMISSED**.

Accordingly, the case is considered **CLOSED** and **TERMINATED**.
